This policy is designed to allow us to maintain the highest quality of merchandise to our customers, while earning you the most money for your consigned items. Caddy Corner accepts women's & men's clothing/shoes/accessories. All merchandise must be in like-new condition.

Please go to our website for a breakdown of the items we are currently taking.

1. All clothing must be freshly cleaned and wrinkle free.
2. Articles will be disposed of if found damaged, stained, or not sellable.
3. CCCB will price all items unless otherwise agreed at the time of consignment.
4. YOU The Consignor, will receive 40% of the selling price.
5. Clothing items stay on the floor for 60 days. After 60 days clothing items are then donated. Purses and jewelry stay on the floor until they sell. Seasonal shoes are taken off the floor around April and September. All items with a priced resale value of \$40 or more WILL NOT be donated after 60 days.
6. All items placed on consignment must remain on the floor for a minimum of sixty (60) days.
7. All money owed to YOU, the consignor, will remain on your account for 6 months from the date of sale. It is YOUR responsibility to collect money within this period or money will be forfeited.
8. Although the best possible care will be taken with your items, Caddy Corner Clothing, LLC is NOT responsible for damage or loss of consignor items for any reason. Consignor waives any claim against the consignee, its landlord and their agents for any damage the goods while in the possessions of Caddy Corner Clothing, LLC.

I HAVE READ, UNDERSTAND AND AGREE TO THE ABOVE CONDITIONS

1. I am the owner of each and every item I have consigned with Caddy Corner Clothing, LLC.
2. I have the full legal power and authority to consign each and every item I have consigned to Caddy Corner Clothing, LLC.
3. I believe that each and every item is what it purports to be, that I have not changed, altered, removed, reattached or otherwise modified the original labels on any consigned item, and I do not believe anyone else has changed the labels either.
4. I have no reason to believe that any item is not what it purports to be.
5. This agreement is binding upon me and my representatives for all purposes.
6. This agreement is signed voluntarily, without any undue influences by anyone.
7. All designer labels are authentic, and they are not knock-offs.
8. I agree I indemnify and hold Caddy Corner and all its owners, managers, members, employees and other representatives from any liability, including attorney fees, expenses, and cost in the result of any breach of any Consignor, including all alleged breach of any Consignor's representation and warranties set forth in this agreement.
